Privacy Policy

The Marketplace and Celebration 2025 is managed by Enterprise Oxfordshire on a not-for-profit basis, with the aim of celebrating and promoting SMEs in Oxfordshire.

The Marketplace and Celebration team at Enterprise Oxfordshire ('we') are committed to protecting and respecting the privacy of all users of the Marketplace and Celebration web pages and the entry process.

To comply with the General Data Protection Regulation (GDPR) our Privacy Policy aims to ensure that you are clear about how we collect and utilise your personal information.

This policy, together with our Enterprise Oxfordshire Marketplace and Celebration Terms and Conditions, sets out how we process any personal data that we collect from you, or that you provide to us. Information we collect from you

What do we do with the information we gather?

Do we disclose your personal data to third parties?

The information provided by you will not be disclosed to any other third party, unless prior consent has been obtained by yourself, or unless we are otherwise required to do so by law.

Entrants – Details we hold on file for Marketplace and Celebration entrants can be accessed only by:



- the Marketplace and Celebration team at Enterprise Oxfordshire
- the Marketplace and Celebration judging panel
- the relevant Marketplace and Celebration category sponsor, who will judge their sponsored category *
- the Marketplace and Celebration headline sponsor, who will judge the overall winner from the winners of each category*

Other than those entities highlighted above, we will not share details held on behalf of entrants with any other third party, without prior permission from the entrant.

Data retention policy

The Marketplace and Celebration judging panel and category sponsor are instructed to delete or shred any information they may hold as soon as they have finished using it for the purpose of the current Marketplace and Celebration.

The Marketplace and Celebration team at Enterprise Oxfordshire will retain the contact details of winners for the purpose of contacting them to offer the opportunity to take part in communications activity relating to this years and future awards.

Your rights

We will always obtain your consent prior to processing your data for marketing purposes or disclosing your data to third parties. Once you have given your consent, you also have the right to withdraw that consent at any time by requesting that we do not process your personal data for these purposes.
